

- d. No Quotation shall be entertained without sealed cover & Gala.
- e. Quotation will be received on or before 31.08.2016 upto 4:00 P.M. only in the Office of the undersigned and the Quotation will be opened on the same day if possible. The Quotation received after 4:00 P.M of the last date shall not be entertained.
- f. Analysis of rate (quoted by party) may be sought for and it will be mandatory for the party to give analysis of the rate.
- g. Defective or incomplete Quotation in any respect shall not be considered.
- h. The bidders will have to accept checking of the traditional ornaments through a committee set up by the Department for determining the quality of the ornaments. The bidders will have to submit still photographs (two copies) of each item for selection.
- i. The successful bidders should supply the ornaments to the Directorate of Information & Cultural Affairs, Government of Tripura, Gandhighat, Agartala within 1 (one) month after receipt of the supply order.
- j. The Director, Information & Cultural Affairs, Govt. of Tripura reserves the right to accept or reject any Expression of Interest based on the design and acceptability and quality of the ornaments only.
